**I AGREE** to take full responsibility for the rental of the Landings Racquet and Swim Club and its property (including: entry area, parking lot area, streets, and other common grassy areas) by keeping it properly maintained while in my care and leaving it in pre-rental conditions. I am responsible for cleaning the facility in accordance with the cleaning contract checklist that will be provided to me when I receive the keys to the facility. I am responsible for any damages incurred during my rental period. \_\_\_\_\_

**I AGREE** that renting of the Landings Clubhouse is not authorized as a sublet (only the renter and their designate party can occupy the clubhouse during the rental period). I understand I am required to return the facility keys and to conduct a walkthrough inspection of the facility and grounds with the Clubhouse Manager at the end of the rental period (**no later than midnight**). Failure to comply with this policy may result in the loss of some or all of my security deposit. \_\_\_\_\_

**I UNDERSTAND** that The Landings swimming pool and pool deck are not authorized for use by my rental party. I also acknowledge that residential swimmers are allowed to use the clubhouse bathroom facilities during pool hours. \_\_\_\_\_

**I UNDERSTAND** I may use the provided hooks on the interior walls to hang decorative items.  
(NOTE: **I cannot** use tape, tacks, nails, staples, or sticky tack anywhere else inside or outside of the clubhouse.) \_\_\_\_\_

**I UNDERSTAND** any unusually loud noise coming from the clubhouse area will be cause for immediate termination of rental period. \_\_\_\_\_

**I UNDERSTAND** the fireplace insert inside the clubhouse is not to be removed for any reason. Only adults will operate its controls. \_\_\_\_\_

**I UNDERSTAND** pets are not permitted in the clubhouse. \_\_\_\_\_

**I UNDERSTAND** if my payment results in a bounced check I will be charged an additional fee of \$35 for insufficient funds. \_\_\_\_\_

**I AGREE** if I cancel my rental reservation within 30 days of the rental date to forfeit the rental fee payment made in advance. \_\_\_\_\_

**I UNDERSTAND** to use only the designated outlets for warming appliances. These outlets are labeled as such. \_\_\_\_\_
